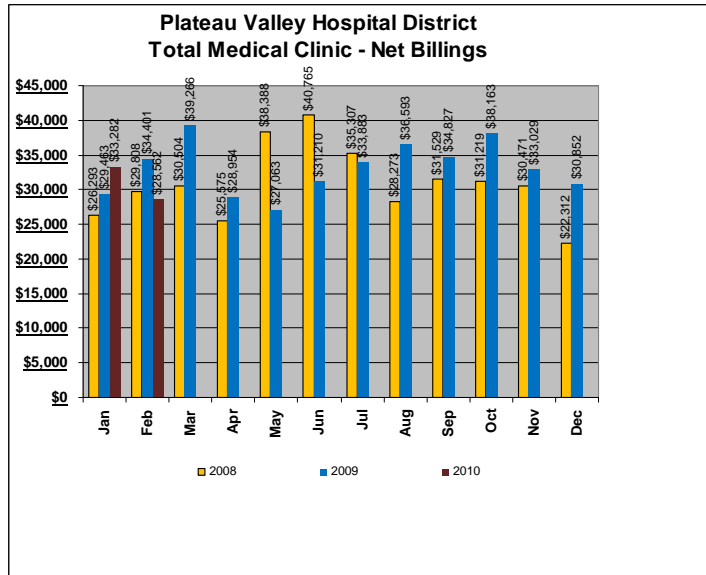
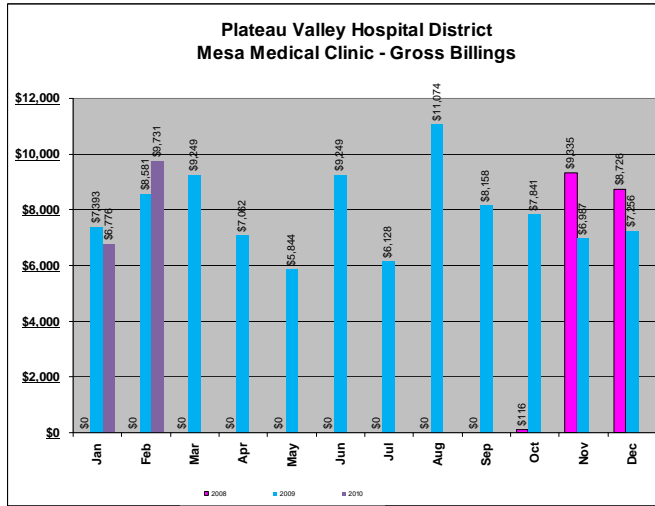
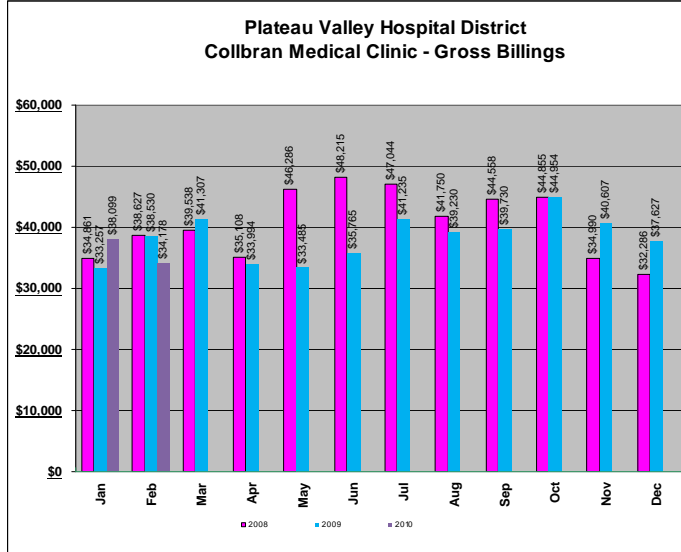
MEETING CALLED TO ORDER AT 17:18 BY HELEN SPENCE, PRESIDENT.

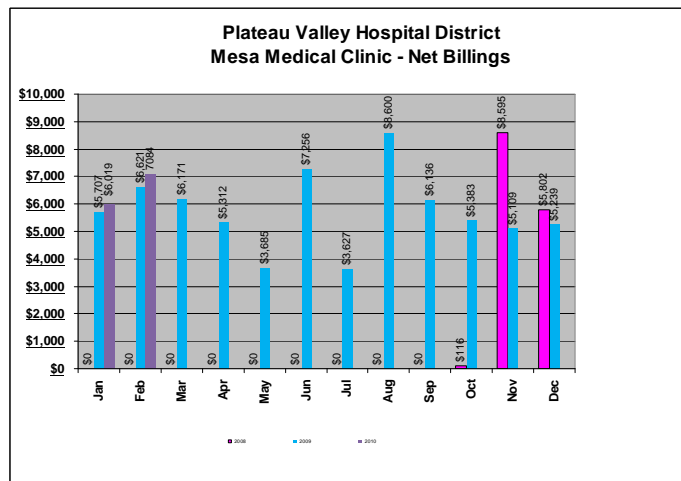
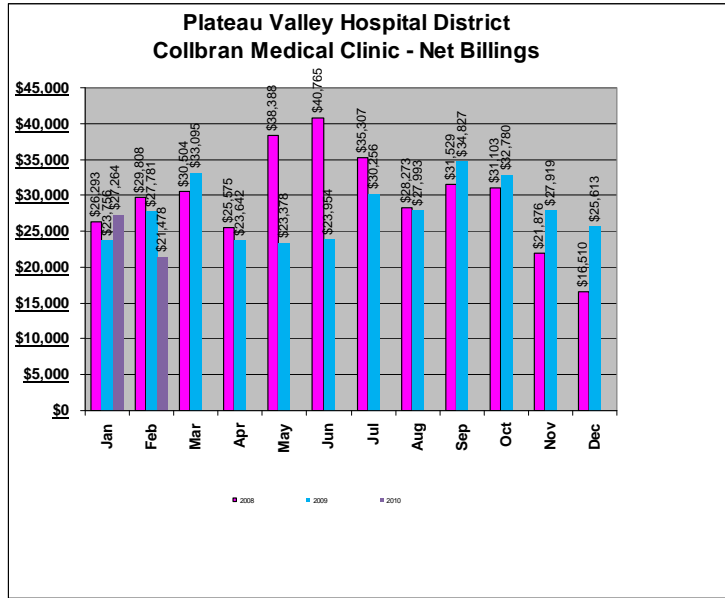
